#### Welcome to our first newsletter of 2017.

Hopefully you will all have had an enjoyable Christmas and New Year break and are ready to face the challenges that 2017 will bring. Whilst Brexit remains a hot national topic, for those of us working with apprenticeships it will be the new Apprenticeship Levy and the introduction of the standards developed by the trailblazer groups.

For those not yet familiar with the employers Apprenticeship Levy, it is being introduced in April this year. It will be payable by all employers at the rate of 0.5% on their total salary bill in excess of £3m per annum. Those employers with a smaller salary bill don't escape the changes and those with 50 or more employees will be required to make a financial contribution.

New Apprenticeship Standards, some of which are available for delivery now, will eventually replace the existing Frameworks. For the time being Frameworks and Standards will operate in parallel. There are some fundamental differences between the two which we are getting to grips with as new information emerges. To support employers through these changes, we are planning an introductory breakfast meeting, on the 13th February.

## **OFSTED – IT'S OFFICIAL**, WE ARE STILL A **"GOOD"** PROVIDER



Towards the end of November 2016 we received a call from Ofsted, informing us that we were to be inspected the following week. Not really a surprise as we had been expecting a call for approximately 12 months. Our last Ofsted visit was in March 2010. As a previously Good provider we were subjected to a 2 day short inspection during which time we had to demonstrate that we were still delivering and performing at a Good (grade 2) level. Thankfully we were able to do this with the help and support of the employers and learners visited by the inspection team. ### THE SAFE USE OF ABRASIVE WHEELS

### MANUAL HANDLING
